METHOD OF STUD SERVICE PAYMENT:

_____ A stud fee of \$ **400.00** and is to be paid prior to extraction of semen.

_____ Owner of female stated below being bred, agrees in return for use of semen to allow Rebecca Hlinak to have 2nd pick puppy, of Rebecca Hlinak's choice, from the litter whelped from this breeding. The puppy is to be delivered to Rebecca Hlinak at the appropriate weaned age of 8 to 10 weeks old, in good health, with all necessary shots, dewormings, written veterinary health examination, and full AKC registration. If the puppy needs to be shipped to Rebecca Hlinak, Rebecca Hlinak will cover appropriate shipping costs. If the female stated below only has one living puppy from this litter and the owner of the stated female cannot give Rebecca Hlinak 2nd pick puppy, the owner of the stated female will pay Rebecca Hlinak the stud fee in the amount of \$400, which will be due immediately upon request and a return service will be granted at no extra charge (shipping and veterinary expenses excluded).

FEMALE OWNER AGREES TO:

- Pay the agreed stud service fee prior to extraction.
- Pay all shipping and veterinary expenses necessary for veterinary extraction, implantation, all necessary paperwork, and any other veterinary expenses for this breeding.
- Agrees stated female is in good health for breeding.
- Agrees to do all appropriate testing on stated female to determine the exact time of ovulation.
- Agrees to notify stud owner of stated female's first sign of heat and/or no sooner than 24-48 hour notice prior to desired shipping and/or extraction dates depending on location.
- Keep the serviced female properly confined following the breeding to ensure no other dog could mate her accidentally, before mating season is finished.
- Agrees to not knowingly sell or transfer puppies as a result of this mating to ANY person or firm connected to, or in the business of, the resale or wholesale of dogs.
- Return shipping carton and ice pack to us within 10 days or pay an extra \$30 for replacement fee.

OUR GUARANTEE:

Provided ALL conditions of this contract have been met, if the stated female fails to conceive or if only one puppy results from this mating, a return service will be provided at no charge (shipping and veterinary expenses excluded) to this same female within 1 year. If the stud is no longer available for the return service, for whatever reason, the stud owner reserves the right to offer a different stud to the female owner. If the stated female fails to conceive on the return service this contract is terminated and no refund will be given.

B & G English Bulldogs is not responsible for any expenses resulting in this breeding (shipping, veterinary, etc...).
